Terms and Conditions of Hire

1. Induction of the Club for Fire Exits and Safety.

It is the responsibility of the Hirer to undertake their inductions on the use of the club room.

2. No Smoking

Normanville Surf Life Saving Club is a non-smoking venue. Designated smoking area is located near the roadway by the bottle shed – see sign.

3. No Alcohol/Drugs

No alcohol other than that sold at the bar or banned drugs are allowed in or about the Club Room and other associated areas such as the balcony and surrounding areas.

4. Care of the Facility

The premises must be left in a clean and tidy condition by the hirer prior to vacating the premises. Please use the disinfectant provided and wipe down tables and other items used as a Covid Safety precaution.

- Ensure all lights, heating or cooling is turned off before you exit the building.
- Ensure all doors are locked.
- Enter the security code if you have a key when exiting the building.

Downstairs, Patrol Room/Office, and Storeroom are NOT to be used.

5. Covid-19 Restrictions

Hirers must comply with the current government COVID-19 restrictions and lockdowns and always adhere to them. QR code or contact tracing must be completed by all guests.

6. Emergency Roller Doors

Emergency Roller Doors Must NOT be blocked at any time (24/7).
