Summary

Data is taken from SLSA Surfguard.

This season saw a significant increase in the numbers of public attending Normanville Beach as shown in Fig 3. This could be due to South Australians holidaying in SA rather than interstate due to Covid 19 border restrictions.

Whilst 41 patrol members were rostered 38 provided 10 hours or more volunteer time. See Fig 2.

There were 5 patrol teams which meant that the teams were patrolling twice a month and, in some cases, depending on the month and public holidays 3 times a month.

Lifesavers additional support for Vacswim, Schools and the Festival Fleurieu Beach event (out of season).

Life savers also provided first aid and rescues in off duty hours.



The total number of members on Surfgaurd as at 24thMay 2021 is 251. The club gender ratio is very close to being 50/50 with slightly more males than females. Nipper figures has shown an increase from the previous season in the 5 + age group, whilst there has been a decrease in patrolling member numbers.

Notes to the Financial Statements

For the year ended 30 June 2021

1 Summary of Significant Accounting Policies

(a) Basis of Preparation

In the officers' opinion, the incorporated association is not a reporting entity because there are no users dependent on general purpose financial statements.

These are special purpose financial statements that have been prepared for the purposes of complying with the South Australian legislation the Associations Incorporation Act 1985 and associated regulations. The officers have determined that the accounting policies adopted are appropriate to meet the needs of the members of Normanville Surf Life Saving Club Inc.

These financial statements have been prepared in accordance with the recognition and measurement requirements specified by the Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the disclosure requirements of AASB 101 'Presentation of Financial Statements', AASB 107 'Statement of Cash Flows', AASB 108 'Accounting Policies, Changes in Accounting Estimates and Errors', AASB 1031 'Materiality', AASB 1048 'Interpretation and Application of Standards' and AASB 1054 'Australian Additional Disclosures', as appropriate for not-for-profit oriented entities.

Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless otherwise stated.

The financial statements have been prepared on an accruals basis and are based on historical costs modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

(b) Comparative Amounts

Comparatives are consistent with prior years, unless otherwise stated.

(c) Income Tax

As the incorporated association is a not-for-profit organisation, it has been granted exemption from the Commissioner of Taxation for the payment of income tax.

(d) Revenue and other income

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the entity and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

All revenue is stated net of the amount of goods and services tax (GST).

(e) Revenue and other income continued

Grant revenue

Government grants are recognised at fair value where there is reasonable assurance that the grant will be received and all grant conditions will be met.

If conditions are attached to the grant which must be satisfied before it is eligible to receive the contribution, the recognition of the grant can be measured reliably.

When grant revenue is received whereby the entity incurs an obligation to deliver economic value directly back to the contributor, this is considered reciprocal transaction and the grant revenue is recognised in the statement of financial position as a liability until the service has been delivered to the contributor, otherwise the grant is recognised as income on receipt.

Other revenue

Other revenue is recognised when it is received or when the right to receive payment is established.

(f) Goods and Services Tax (GST)

Revenue, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO).

Receivables and payables are stated inclusive of GST.

Cash flows in the statement of cash flows are included on a gross basis and the GST component of cash flows arising from investing and financing activities which is recoverable from, or payable to, the taxation authority is classified as operating cash flows.

(g) Property, Plant and Equipment

Plant and equipment

Plant and equipment are measured using the cost model.

Building/Property

Buildings are measured using the cost model. The Board of management has determined that buildings will not be depreciated.

Depreciation

The depreciable amount of plant and equipment, except for freehold land, buildings, intangibles and computer equipment, are depreciated on a diminishing value method from the date that management determine that the asset is available for use. Intangibles and computer equipment are depreciated on a prime cost basis.

Assets held under a finance lease and leasehold improvements are depreciated over the shorter of the term of the lease and the assets useful life.

(i) Cash and cash equivalents

Cash and cash equivalents comprises cash on hand, demand deposits and short-term investments which are readily convertible to known amounts of cash and which are subject to an insignificant risk of change in value.

Bank overdrafts also form part of cash equivalents for the purpose of the statement of cash flows and are presented within current liabilities on the statement of financial position.

(j) Employee benefits

Provision is made for the Company's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits that are expected to be settled within one year have been measured at the amounts expected to be paid when the liability is settled.

(k) Economic dependence

Normanville Surf Life Saving Club Inc. is dependent on the funding from federal government grants for the majority of its revenue used to operate the business. At the date of this report the directors have no reason to believe the funding from federal government grants will not continue to support Normanville Surf Life Saving Club Inc.

(I) Inventories

Inventories are measured at the lower of cost and current replacement cost.

Inventories acquired at no cost, or for nominal consideration are valued at the current replacement cost as at the date of acquisition.

Report on the Audit of the Financial Report

Qualified Opinion

We have audited the financial report, being a special purpose financial report, of Normanville Surf Life Club Inc ("the **Association**"), which comprises the statement of financial position as at 30 June 2021, the statement of profit or loss & other comprehensive income, statement of changes in equity for the year then ended, a summary of significant accounting policies, other explanatory notes and the statement by the board of management.

In our opinion, except for the effects of the matter described in the Basis of Qualified Opinion section of our report, the accompanying financial report of the Association is in accordance with Division 60 of the Australian Charities and Not-for-profits Commission Act 2012, including:

- (a) giving a true and fair view of the registered entity's financial position as at 30 June 2021 and of its financial performance for the year ended; and
- (b) complying with Australian Accounting Standards to the extent described in Note 1, and Division 60 of the Australian Charities and Not-for-profits Commission Regulation 2013.

Basis of Qualified Opinion

Cash donations, cash receipts and fundraising income are significant sources of revenue for the Association. The Association has determined that it is impracticable to establish control over the collection of cash receipts, donations and fundraising income prior to entry into its financial records. Accordingly, as the evidence available to us regarding revenue from this source was limited, our audit procedures with respect to cash receipts, donations and fundraising income had to be restricted to the amounts recorded in the financial records. We therefore are unable to express an opinion on whether the recorded cash receipts of the Association are complete.

We conducted our audit in accordance with Australian Auditing Standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. We are independent of the registered entity in accordance with the Australian Charities and Not-for-profits Commission Act 2012 (ACNC Act) and the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 Code of Ethics for Professional Accountants (the Code) that are relevant to our audit of the financial report in Australia. We have also fulfilled our other ethical responsibilities in accordance with the Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of Matter - Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared for the purpose of fulfilling the registered entity's financial reporting responsibilities under the ACNC Act. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.
